

## 2024 RACER PIT PARKING APPLICATION & POLICIES

New England Dragway racers may leave their race vehicle inside the facility during the week under the following provisions outlined below. Failure to comply with these provisions may result in the vehicle being towed from the facility at the owner's expense, loss of parking privileges, and other disciplinary actions deemed appropriate by track officials.

### Please Respect The Following Rules:

1. All RV's, race vehicles, or trailers that will remain on the property in a reserved spot must be parked in the upper pit area in the spot that they are assigned. Those without a reserved spot must move all equipment up past the scale buildings & storage containers when not racing.
2. All trailers will be parked at least 25 feet away from the pro car asphalt area. ***In general, no vehicle may be left on any paved lower pit area, or in the fenced in grass area commonly known as the car show area during the week.***
3. The competition number of the vehicle as well as a Pit Parking Permit must be clearly displayed on any trailer or vehicle left inside the facility. Pit Parking Permit must be displayed on the backside of the equipment being left on the property.
4. No vehicle may be left on New England Dragway property unless a Pit Parking Application & Policies Form has been signed and is on file for the current season, and the Pit Parking Permit is correctly affixed to the equipment as previously stated. This provision includes but is not limited to race cars, trailers, RV's, two or three or four-wheeled pit/tow vehicles, and golf carts. No chairs, couches, tables, etc. are allowed to be left on the property unless it is secured inside an enclosed trailer and must not be visible Monday through Friday.
5. The saving of pit spaces is not permitted. All pit parking is on a first come, first served basis. If, in the opinion of New England Dragway officials a vehicle is occupying more than a reasonable amount of pit space for their vehicle, they may require that vehicle to be relocated.
6. At the conclusion of the race season all vehicles must be removed from the property no later than the last scheduled race day on **October 30, 2024**. New England Dragway, Inc. accepts no responsibility for the security or safekeeping of any vehicle, or personal property left on its property.
7. **Due to continued hardships regarding personal property left on NED grounds all individuals will now be required to pay a \$10 fee, as well as acquire and display a parking pass, prior to parking. Please check with an NED official before parking, especially if you are unsure of where to park.** Initials: \_\_\_\_\_

**In preparation for Import Face Off, Street Outlaws, H-DAY, NHRA New England Nationals, The Gear Jammer Truck Show, and the NHRA Lucas Oil Regional Series Race, racers with equipment on NED property shall adhere to the following:**

**Import Face Off - May 5, 2024:** All RV's, race vehicles and/or trailers must be moved to the designated area on NED property by the end of racing **April 28, 2024**. *If you are racing on May 4, all equipment must be moved to a designated area by the end of racing on May 4, 2024.* \* Initials: \_\_\_\_\_

**Street Outlaws - May 10 & 11, 2024:** All RV's, race vehicles and/or trailers must be moved to the designated area or removed from NED property by the end of racing on **May 4, 2024**. \* Initials: \_\_\_\_\_

**NHRA New England Nationals - May 31-June 2, 2024:** All RV's, race vehicles and/or trailers must be removed from NED property by the end of racing on **May 19, 2024**. *This includes all reserved pit spaces, as well as the dirt / grass areas in the upper pit area. If you are racing on May 25 or 26, all equipment must be removed by the end of racing on May 26, 2024. If you are racing at the event, all equipment to be used in the event must be moved to the designated area past the storage containers by the end of racing on May 26, 2024.* \* All equipment that will not be used in the event must be removed from NED property by the end of racing on **May 26, 2024**. *If you are not racing the event, your equipment must be removed from the NED property.* Initials: \_\_\_\_\_

**Gear Jammer Truck Show - July 19 & 20, 2024:** All RV's, race vehicles and/or trailers must be moved to the designated area or removed from NED property by the end of racing on **July 7, 2024**. *This includes all reserved pit spaces, as well as the dirt / grass areas in the upper pit area. If you are racing on July 13 or 14, all equipment must be removed or moved to a designated area by the end of racing on July 14, 2024.* \* Initials: \_\_\_\_\_

**HDAY - August 10 & 11, 2024:** All RV's, race vehicles and/or trailers must be removed from NED property by the end of racing on **July 28, 2024**. *If you are racing on August 3 or 4, all equipment must be removed or moved to a designated area by the end of racing on August 4, 2024.* \* Initials: \_\_\_\_\_

**NHRA Lucas Oil Regional Series Race - August 16 & 17, 2024:** All RV's, race vehicles and/or trailers must be removed from NED property or moved to the designated area by the end of racing on **August 4, 2024**. *This includes all reserved pit spaces, as well as the dirt / grass areas in the upper pit area. If you are racing at the event, all equipment to be used in the event must be moved to the designated area by the end of racing on August 4, 2024. All equipment that will not be used in this event must be removed from NED property by the end of racing on August 4, 2024.* \* Initials: \_\_\_\_\_

**Import Face Off - September 29, 2024:** All RV's, race vehicles and/or trailers must be moved to the designated area on NED property by the end of racing **September 22, 2024**. *If you are racing on September 28 all RV's, race vehicles, and/or trailers must be removed from NED property or moved to a designated area by the end of racing on September 28, 2024.* \* Initials: \_\_\_\_\_

**\*\*\*Any RV's, race vehicles, and/or trailers, etc. left on the property will be towed at the owner's expense. New England Dragway and/or the towing company will not be responsible for any damages or loss of possessions or equipment.\*\*\*** Initials: \_\_\_\_\_



*\* Any vehicle left on the premises of New England Dragway is left at the owner's risk. New England Dragway, Inc. will not be responsible for any loss to any vehicle, trailer, motor home or other personal property that is left on New England Dragway property, be it from fire, theft, vandalism, act of nature, or the alleged negligence of New England Dragway Inc. The owner of any property, including vehicles and trailers, left at New England Dragway, agrees to indemnify and hold New England Dragway, Inc., harmless from any claims arising from the presence of the vehicle, trailer, or other personal property at New England Dragway.*

**\* NOTE:** If the date that race vehicles and/or trailers are supposed to be moved out by is cancelled due to rain, all must be removed before property is secured. At the discretion of New England Dragway management, violations of these policies will result in the revocation of parking privileges for a period of (1) year.
