

2023 RACER PARKING APPLICATION & PARKING POLICY

- General Pit Parking -

New England Dragway racers may leave their race vehicle inside the facility during the week under the following provisions outlined below. Failure to comply with these provisions may result in the vehicle being towed from the facility at the owner's expense, loss of parking privileges, and other disciplinary actions deemed appropriate by track officials.

Please Respect The Following Rules:

- 1. All RV's, race vehicles, or trailers that will remain on the property must be parked in the upper pit area.
- 2. All trailers will be parked at least 25 feet away from the pro car asphalt area. *In general, no vehicle may be left on any paved lower pit area, or in the fenced in grass area commonly known as the car show area during the week.*
- 3. The competition number of the vehicle as well as a Pit Parking Permit must be clearly displayed on any trailer or vehicle left inside the facility.
- 4. No vehicle may be left on New England Dragway property unless a parking policy acknowledgment form has been signed and is on file for the current season. This provision includes, but is not limited to race cars, trailers, RV's, two or three or four-wheeled pit/tow vehicles, and golf carts. No chairs, couches, tables, etc. are allowed to be left on the property unless it is secured inside an enclosed trailer and must not be visible Monday-Friday.
- 5. The saving of pit spaces is not permitted. All pit parking is on a first come, first served basis. If, in the opinion of New England Dragway officials a vehicle is occupying more than a reasonable amount of pit space for their vehicle, they may require that vehicle to be relocated.
- 6. At the conclusion of the race season all vehicles must be removed from the property no later than the last scheduled race day on October 29, 2023. New England Dragway, Inc. accepts no responsibility for the security or safekeeping of any vehicle, or personal property left on its property.
- 7. Due to continued hardships regarding personal property left on NED grounds all individuals will now be required to pay a \$10 fee, as well as acquire and display a parking pass, prior to parking. Please check with an NED official before parking, especially if you are unsure of where to park. Initials:

In preparation for Import Face Off, Street Outlaws, H-DAY, NHRA Camping World New England Nationals, and the NHRA Lucas Oil Regional Series Race, racers with equipment on NED property shall adhere to the following:

Import Face Off - May 7, 2023: All RV's, race vehicles and/or trailers must be moved to the designated area on NED property by the end of racing April 30, 2023. If you are racing on May 6, all RV's, race vehicles, and/or trailers must be moved to a designated area by the end of racing on May 6, 2023.* Initials:

NHRA New England Nationals Race - June 2-4, 2023: All RV's, race vehicles and/or trailers must be removed from NED property by the end of racing on May 26, 2023. This includes all reserved pit spaces, as well as the dirt / grass areas in the upper pit area. If you are racing on May 27 or 28, all equipment must be removed by the end of racing on May 28, 2023. If you are racing at the event, all equipment must be moved to the designated area past the storage containers by the end of racing on May 28, 2023. You MUST register with the NED office by showing your racer registration to get a National Event parking sticker.* Initials:

Street Outlaws - June 30 & July 1, 2023: All RV's, race vehicles and/or trailers must be moved to the designated area or removed from NED property by the end of racing on **June 23, 2023**. If you are racing on June 24 or 25, all RV's, race vehicles, and/or trailers must be moved to a designated area by the end of racing on **June 25, 2023**.* Initials:

H-DAY - August 12 & 13, 2023: All RV's, race vehicles and/or trailers must be removed from NED property by the end of racing on August 5, 2023. If you are racing on August 5 or 6, all RV's, race vehicles, and/or trailers must be moved to a designated area by the end of racing on August 6, 2023. * Initials:

NHRA Lucas Oil Regional Series Race - August 25 & 26, 2023: All RV's, race vehicles and/or trailers must be removed from NED property or moved to the designated area by the end of racing on August 16, 2023. If you are racing on August 19 or 20, all equipment must be moved to a designated area by the end of racing on August 20, 2023. This includes all reserved pit spaces, as well as the dirt / grass areas in the upper pit area. If you are racing at the event, all equipment must be moved to the designated area by the end of racing on August 20, 2023.* Initials:

Import Face Off - October 1, 2023: All RV's, race vehicles and/or trailers must be moved to the designated area on NED property by the end of racing **September 24, 2023**. *If you are racing on September 30, all RV's, race vehicles, and/or trailers must be removed from NED property or moved to a designated area by the end of racing on September 30, 2023.* Initials:*

Any RV's, race vehicles, and/or trailers, etc. left on the property will be towed at the owner's expense. New England Dragway and/or the towing company will not be responsible for any damages or loss of possessions or equipment. Initials:



- * Any vehicle left on the premises of New England Dragway is left at the owner's risk. New England Dragway, Inc. will not be responsible for any loss to any vehicle, trailer, motor home or other personal property that is left on New England Dragway property, be it from fire, theft, vandalism, act of nature, or the alleged negligence of New England Dragway Inc. The owner of any property, including vehicles and trailers, left at New England Dragway, agrees to indemnify and hold New England Dragway, Inc., harmless from any claims arising from the presence of the vehicle, trailer, or other personal property at New England Dragway.
- *NOTE: If the date that race vehicles and/or trailers are supposed to be moved out by is cancelled due to rain, all must be removed before property is secured. At the discretion of New England Dragway management, violations of these policies will result in the revocation of parking privileges for a period of (1) year.
